CHANGE IN SHAREHOLDING - INCREASE OF SHAREHOLDING OF THE CONTROLLING SHAREHOLDER

This announcement is made by Freotech Road Recycling Technology (Holdings) Limited (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong) to provide its shareholders and potential investors with up-to-date information in relation to the increase of the shareholding of Freotech (Cayman) Ltd. (“**Freotech Cayman**”), a company beneficially owned by Mr. Sze Wai Pan (“**Mr. Sze**”). Mr. Sze is the controlling shareholder, the chairman, the chief executive officer and an executive director of the Company.

INCREASE OF SHAREHOLDING

The board of directors of the Company has been informed that on 22 September 2014, 23 September 2014 and 24 September 2014, Freotech Cayman acquired in total an additional 600,000 ordinary shares (representing approximately 0.06% of the issued share capital of the Company as at the date of this announcement) of the Company on the secondary market at an average consideration per share of HK\$1.7065. Following the acquisition, Mr. Sze together with his beneficially owned companies (which include Freotech Technology Limited, Freotech (BVI) Limited and Freotech Cayman), has increased his total interest in the Company to 524,965,260 ordinary shares of the Company, representing approximately 48.65% of the issued share capital of the Company as at the date of this announcement.

Mr. Sze remarked that he remained confident about the future prospects of the Company and optimistic about the road maintenance market in the People’s Republic of China.
