### **STRATEGIC COOPERATION WITH JIANGSU PROVINCIAL COMMUNICATION HIGHWAY DEPARTMENT**

The board of directors (the **"Board"**) of Fretech Road Recycling Technology (Holdings) Limited (the **"Company"**) is pleased to announce that on 11 November 2014, the Company entered into a strategic cooperation agreement (**"Strategic Agreement"**) with Jiangsu Provincial Communication Highway Department\* (江蘇省交通運輸廳公路局) (**"Jiangsu Highway Department"**). Pursuant to the Strategic Agreement, the Company and Jiangsu Highway Department will cooperate in the development of new maintenance materials, technology, machinery products, marketing, promotion, industrialization and research and development in areas including recycling technology in asphalt pavement maintenance, the production of road maintenance accessory equipment, road rapid maintenance technology and high performance road maintenance materials. Jiangsu Highway Department will provide the specification of the requisite technology, equipment and development conditions, offer a research and development platform and resources to the Company, and support the application of the research and development results. The Company will focus on in-depth research on recycling technology in asphalt pavement maintenance and the development of cost-efficient and reliable maintenance equipment of an international standard. The supplemental agreement in respect to the detailed terms of the Strategic Agreement will be further entered into by the Company and Jiangsu Highway Department. The Company will issue further announcement to update its shareholders on any new material development of the aforesaid matter as and when appropriate.

#### **Information of Jiangsu Highway Department**

Jiangsu Highway Department is the government department and responsible for the construction, maintenance and management of different types of road including all of the state roads, highways and county roads in the Jiangsu Province of the People's Republic of China.

The Company believes that the Strategic Agreement will assist the marketing, promotion and research and development of new technology in road maintenance and machinery by our Company and its subsidiaries (the “**Group**”). The Company believes that such cooperation could enhance the Group’s core competitiveness and potentially lead to more business opportunities for the Group in the future.
