### 1. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of certain resolutions to be proposed at the Annual General Meeting for (i) the re-election of the retiring Directors; (ii) the granting to the Directors of the Share Repurchase Mandate and the Issuance Mandate to repurchase Shares and to issue new Shares respectively; and (iii) the notice of the Annual General Meeting.

## **LETTER FROM THE BOARD**

### **2. PROPOSED RE-ELECTION OF RETIRING DIRECTORS**

In accordance with Article 84 of the Articles of Association, Ms. Sze Wan Nga, Mr. Chan Kai King and Mr. Lau Ching Kwong shall retire at the Annual General Meeting. All of the above retiring Directors, being eligible, will offer themselves for re-election at the Annual General Meeting.

In accordance with Article 83 of the Articles of Association, Dr. Chan Yan Chong, who was appointed as non-executive Director by the Board on 31 October 2016, being eligible, will offer himself for re-election at the Annual General Meeting.

Mr. Lau Ching Kwong, being an independent non-executive Director eligible for re-election at the Annual General Meeting, has made a confirmation of independence pursuant to Rule 3.13 of the Listing Rules. Further, the Company is of the view that Mr. Lau Ching Kwong meets the independence guidelines set out in Rule 3.13 of the Listing Rules and is independent in accordance with the terms of the guidelines.

Biographical and other details of the above retiring Directors are set out in Appendix I to this circular. At the Annual General Meeting, separate ordinary resolutions will be proposed to approve their re-election.

### **3. PROPOSED GRANTING OF GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES**

At the annual general meeting of the Company held on 27 May 2016, general unconditional mandates were granted to the Directors to repurchase and issue Shares respectively. Such mandates will lapse at the conclusion of the Annual General Meeting. In order to give the Company the flexibility to repurchase and issue Shares, if and when appropriate, the following ordinary resolutions will be proposed at the Annual General Meeting to approve:

- (a) the granting of the Share Repurchase Mandate to the Directors to repurchase Shares not exceeding 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of proposed ordinary resolution contained in Ordinary Resolution 4 of the notice of the Annual General Meeting as set out on page 17 of this circular (i.e. an aggregate nominal amount of Shares up to HK\$10,790,000 (equivalent to 107,900,000 Shares) on the basis of the issued share capital of the Company as at the Latest Practicable Date and no further Shares being issued or repurchased before the Annual General Meeting);
- (b) the granting of the Issuance Mandate to the Directors to allot, issue or deal with additional Shares of not exceeding 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of proposed ordinary resolution contained in Ordinary Resolution 5 of the notice of the Annual General Meeting as set out on pages 17 to 18 of this circular (i.e. an aggregate nominal amount of Shares up to HK\$21,580,000 (equivalent to 215,800,000 Shares) on the

basis of the issued share capital of the Company as at the Latest Practicable Date and no further Shares being issued or repurchased before the Annual General Meeting); and

- (c) the extension of the Issuance Mandate by adding to it the aggregate nominal amount of any Shares repurchased by the Company pursuant to the Share Repurchase Mandate.

The Share Repurchase Mandate and the Issuance Mandate will continue in force until the conclusion of the next annual general meeting of the Company held after the Annual General Meeting or any earlier date as referred to in the proposed ordinary resolutions contained in Ordinary Resolutions 4 and 5 of the notice of the Annual General Meeting as set out on pages 17 to 18 of this circular.

With reference to the Share Repurchase Mandate and the Issuance Mandate, the Directors wish to state that they have no immediate plan to repurchase any Shares or issue any new Shares pursuant thereto.

An explanatory statement required by the Listing Rules to provide Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the granting of the Share Repurchase Mandate is set out in Appendix II to this circular.

#### **4. ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT**

The notice of the Annual General Meeting is set out on pages 16 to 19 of this circular.

Pursuant to the Listing Rules and the Articles of Association, any vote of Shareholders at a general meeting must be taken by poll. An announcement on the poll vote results will be published by the Company after the Annual General Meeting in the manner prescribed under Rule 13.39(5) of the Listing Rules.

A form of proxy for use at the Annual General Meeting is enclosed with this circular and such form of proxy is also published on the websites of Hong Kong Exchanges and Clearing Limited (<http://www.hkexnews.hk>) and the Company (<http://www.freetech-holdings.com>). To be valid, the form of proxy must be completed and signed in accordance with the instructions printed thereon and deposited, together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority at the Company's branch share registrar in Hong Kong, Tricor Investor Services Limited, at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. Completion and delivery of the form of proxy will not preclude you from attending and voting at the Annual General Meeting or any adjournment thereof if you so wish. In such event, the instrument appointing a proxy shall be deemed to be revoked.

### 5. RECOMMENDATION

*The following are details of the Directors who will retire and, being eligible, offer themselves for re-election at the Annual General Meeting.*

## **POSITION, EXPERIENCE AND LENGTH OF SERVICE**

### **(1) Ms. Sze Wan Nga**

Ms. Sze Wan Nga (“**Ms. Sze**”), aged 43, was appointed an executive Director and a member of remuneration committee of the Company in June 2011 and June 2013, respectively. She joined the Group in September 2000. She is also a director of several major PRC operating subsidiaries of the Group. Ms. Sze obtained the Master of Business Administration degree from Hong Kong Baptist University in November 2004, and a Bachelor of Combined Science degree from Hong Kong Baptist University in November 1995, majoring in applied physics. She has over 16 years of experience in executive management and is primarily responsible for finance and overall operation of the Group. Ms. Sze is the sister of Mr. Sze Wai Pan, the founder of the Group and Chairman, chief executive officer and one of the executive directors of the Company.

### **(2) Mr. Chan Kai King**

Mr. Chan Kai King (“**Mr. Chan**”), aged 49, was appointed an executive Director in August 2012. He joined the Group in September 2000. Mr. Chan became the head of the engineering and mechanical design institute of a major operating subsidiary of the Group in May 2005. Mr. Chan received a master’s degree in mechanical engineering in October 2011 from the Hong Kong Polytechnic University and a bachelor’s degree in manufacturing engineering in December 1994 from the City Polytechnic of Hong Kong (currently known as City University of Hong Kong). Mr. Chan has over 10 years of experience in the mechanical engineering industry and is primarily responsible for research and development of products and technology of the Group.

**(3) Mr. Lau Ching Kwong**

Mr. Lau Ching Kwong (“**Mr. Lau**”), aged 74, joined in August 2012 as an independent non-executive Director. He is also a member of each of the audit committee and the nomination committee of the Company. Mr. Lau has been an executive director of transportation of AECOM Asia Co. Ltd (艾奕康有限公司) since June 2003, mainly focusing on consulting work for infrastructure constructions in the PRC. Mr. Lau worked for the Government of Hong Kong for over thirty years, mainly responsible for design and construction of public works. He served many roles including the chief engineer of Tsing Ma Bridge, the deputy director of the Highways Department (路政署), the director of the Civil Engineering and Development Department (土木工程署) respectively. Mr. Lau obtained a doctorate degree in engineering from Tsinghua University (清華大學) in June 1998, a master’s degree majoring in bridge engineering in December 1970 from the University of Surrey, and a diploma in building in July 1963 from Hong Kong Technical College (now known as the Hong Kong Polytechnic University). Mr. Lau is a first class registered structural engineer recognised by the National Administration Board of Engineering Registration (Structural) of the PRC (全國註冊工程師管理委員會(結構)) in March 2002. He is a council member of China Civil Engineering Society (中國土木工程學會) since 2002 and a standing committee member since December 2008. Mr. Lau has over 40 years of experience in civil engineering.

**(4) Dr. Chan Yan Chong**

Dr. Chan Yan Chong (“**Dr. Chan**”), aged 65, was appointed as a non-executive director of the Company in October 2016. He graduated from Nanyang University in Singapore with a degree in Mathematics. Then he obtained a Master’s degree in Operational Research at Lancaster University and Doctorate in Management Sciences at Manchester University. Dr. Chan worked as programme director for the Master of Business Administration degree programme and associate professor in the Department of Management Sciences at City University of Hong Kong. He is currently a director of Au Chan Investment Limited. In 2001, Dr. Chan won the best commercial application research award from City University of Hong Kong. In 2007, Dr. Chan was awarded the Medal of Honor (M.H.) from the Government of Hong Kong, and Nanyang Alumnus Award from Nanyang Technological University, and obtained the International Financial Awards of Excellence for his Distinguished Financial Research by Chinese Institute of Certified Financial Planners. He has published 50 professional books and more than 5,000 articles, and is also a feature column writer for many newspaper and magazines. Dr. Chan is currently an independent non-executive director of Shanghai Jiada Withub Information Industrial Company Limited\* (上海交大慧谷信息產業股份有限公司) (Stock Code: 8205), shares of which are listed on the Growth Enterprise Market of the Stock Exchange.

**DIRECTORS' EMOLUMENTS****(1) Ms. Sze Wan Nga**

Ms. Sze has entered into a service contract with the Company for a term of three years commencing from 7 June 2013, which will be automatically renewed for a consecutive term of three years, until terminated by not less than three months' written notice. Under the service contract, Ms. Sze is entitled to an annual emolument of HK\$960,000. The emolument excludes bonus and other benefits, which may be granted at the discretion of the Company. The Director's fees and other emoluments are determined by the Board with reference to her duties, responsibilities and performance as well as the market rate of a director of other Hong Kong listed companies.

**(2) Mr. Chan Kai King**

Mr. Chan has entered into a service contract with the Company for a term of one year effective from 7 June 2013, which will be automatically renewed for a consecutive term of three years, until terminated by not less than three months' written notice. Under the service contract, Mr. Chan is entitled to an annual emolument of HK\$876,000. The emolument excludes bonus and other benefits, which may be granted at the discretion of the Company. The Director's fees and other emoluments are determined by the Board with reference to his duties, responsibilities and performance as well as the market rate of a director of other Hong Kong listed companies.

**(3) Mr. Lau Ching Kwong**

Mr. Lau has entered into a service contract with the Company for a term of two years effective from 26 June 2013. Mr. Lau has entered into a renewal contract with the Company on 26 June 2015 for a term of two years effective from 26 June 2015 until terminated by not less than three months' written notice. Under the renewal contract, Mr. Lau is entitled to an annual emolument of HK\$200,000. The emolument excludes bonus and other benefits, which may be granted at the discretion of the Company. The Director's fees and other emoluments are determined by the Board with reference to his duties, responsibilities and performance as well as the market rate of a director of other Hong Kong listed companies.

**(4) Dr. Chan Yan Chong**

Dr. Chan has entered into a service contract with the Company for a term of two years effective from 31 October 2016 until terminated by not less than three months' written notice. Under the service contract, Dr. Chan is entitled to an annual emolument of HK\$200,000. The emolument excludes bonus and other benefits, which may be granted at the discretion of the Company. The Director's fees and other emoluments are determined by the Board with reference to his duties, responsibilities and performance as well as the market rate of a director of other Hong Kong listed companies.

**INFORMATION THAT NEEDS TO BE DISCLOSED AND MATTERS THAT NEED TO  
BE BROUGHT TO THE ATTENTION OF THE SHAREHOLDERS**

Save as disclosed above, there are no other matters relating to the re-election of Ms. Sze, Mr. Chan, Mr. Lau and Dr. Chan that need to be brought to the attention of the Shareholders and there is no information which is required to be disclosed pursuant to any of the requirements of Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

*The following is an explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the Ordinary Resolutions to be proposed at the Annual General Meeting in relation to the granting of the Share Repurchase Mandate.*

## **1. SHARE CAPITAL**

As at the Latest Practicable Date, the issued share capital of the Company comprised 1,079,000,000 Shares.

Subject to the passing of Ordinary Resolution 4 of the notice of the Annual General Meeting in respect of the granting of the Share Repurchase Mandate and on the basis that the issued share capital of the Company remains unchanged as at the date of the Annual General Meeting, i.e. being 1,079,000,000 Shares, the Directors would be authorised under the Share Repurchase Mandate to repurchase, during the period in which the Share Repurchase Mandate remains in force, an aggregate nominal amount of Shares up to HK\$10,790,000 (equivalent to 107,900,000 Shares), representing 10% of the aggregate nominal amount of Shares in issue as at the date of the Annual General Meeting.

## **2. REASONS FOR SHARE REPURCHASE**

The Directors believe that the granting of the Share Repurchase Mandate is in the best interests of the Company and the Shareholders.

Repurchases of Shares may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders.

## **3. FUNDING OF REPURCHASE**

Repurchases of Shares must be funded out of funds legally available for such purpose in accordance with its Memorandum and Articles of Association and the applicable laws and regulations of the Cayman Islands.

The Company is empowered by its Memorandum and Articles of Association to repurchase Shares. The laws of the Cayman Islands provide that a purchase of shares may be made (to the extent of the par value of such shares) out of profits or the proceeds of a fresh issue of shares made for such purpose or, out of capital, provided that the Company is able to pay its debts as they fall due in the ordinary course of business and the purchase is authorised by its Articles of Association and subject to the laws of the Cayman Islands. Any premium payable on a purchase may be made out of profits, the Company's share premium account or out of capital, provided that the Company is able to pay its debts as they fall due in the ordinary course of business and the purchase is authorised by its Articles of Association and subject to the laws of the Cayman Islands.

**4. IMPACT OF REPURCHASE**

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2016) in the event that the Share Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Share Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

**5. MARKET PRICES OF SHARES**

**6. UNDERTAKING**

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their close associates, have any present intention to sell any Shares to the Company under the Share Repurchase Mandate if such is approved by the Shareholders and exercised by the Board.

Accordingly, a Shareholder or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholders' interest, could obtain or consolidate control of the Company and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best knowledge and belief of the Company, (i) Freetech Technology Limited ("**Freetech**", which is solely owned by Mr. Sze Wai Pan ("**Mr. Sze**"), the chairman, executive Director and chief executive officer) holds 527,006,260 Shares, representing approximately 48.84%; (ii) Intelligent Executive, which is solely owned by Ms. Sze Wan Nga ("**Ms. Sze**"), an executive Director) holds 29,640,000 Shares and Ms. Sze holds 200,000 shares held under equity derivatives, together representing approximately 2.77%; (iii) Smart Executive Group Limited ("**Smart Executive**", which is solely owned by Ms. Sze On Na) holds 50,720,520 Shares, representing approximately 4.70%; and (iv) Smart Vision Partner Limited ("**Smart Vision**", which is solely owned by Mr. Sze Wai Pang) holds 23,888,000 Shares, representing approximately 2.21%. As Ms. Sze and Ms. Sze On Na are the sisters of Mr. Sze and Mr. Sze Wai Pang is the brother of Mr. Sze, all of them had been treated as parties acting in concert (as defined under the Takeovers Code) and were deemed to be a group of controlling shareholders of the Company. On the basis of the aggregate shareholding of Freetech, Intelligent Executive and Ms. Sze, Smart Executive and Smart Vision, representing approximately 58.52%, in the event that the Directors exercise in full the power to repurchase Shares in accordance with the terms of the relevant ordinary resolution to be proposed at the Annual General Meeting, the interest of a group of controlling shareholders in the issued Shares would be increased to approximately 65.02% of the issued share capital of the Company.

The Directors are not aware of any consequences which would give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code.

The Listing Rules prohibit a company from making repurchase of its shares on the Stock Exchange if the result of the repurchase would be that less than 25% (or such other prescribed minimum percentage as determined by the Stock Exchange) of the company's issued share capital would be in public hands. The Directors do not propose to repurchase Shares, which would result in less than the prescribed minimum percentage of Shares in public hands.
