SUCCESSFUL FIRST SALE OF THE EQUIPMENT TO A CONTRACTOR IN MALAYSIA

This announcement is made by Fretech Road Recycling Technology (Holdings) Limited (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) is pleased to announce that in the second half of June 2018, Fretech Road Maintenance Engineering Co., Limited (“**Fretech Engineering**”), an indirect wholly-owned subsidiary of the Company, successfully sold and delivered an asphalt pavement maintenance (“**APM**”) standard series equipment for the first time to an independent third party contractor (the “**Contractor**”) based in Malaysia and provided the relevant APM equipment operation training to the Contractor. The Board believes that due to heavy traffic and lack of daily road maintenance, the condition of the municipal roads in Kuala Lumpur, Malaysia, is poor and has lot of potholes and therefore, the introduction to the Contractor of the Company’s customised APM standard series equipment with high flexibility can reduce traffic disturbance in the course of road maintenance in Kuala Lumpur, Malaysia and also can realise Kuala Lumpur Municipal Government’s “Zero Pothole Policy” in respect of its municipal roads.

The Company considers that following the successful first sale of modular series equipment to the Republic of Korea and of its APM standard series equipment to Malaysia, the Company will continue to seek overseas business opportunities to expand its business in the countries along the “One Belt One Road” and four Asian tigers.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
